In consideration of Golden Automotive Group d/b/a Automotive (hereinafter "Planet") loaning me the above described motor vehicle, I hereby accept full responsibility for its operation and agree that I will not operate it contrary to the laws of jurisdiction in which it is being operated. I also agree to reimburse said lender, upon demand for any costs, expenses, losses or damage, including reasonable attorney fees, arising from any claim or claims for personal injury or property damage to others or myself arising out of the use, possession or operation of said vehicle. I agree that I will not allow anyone under 21 years of age to operate this vehicle. I further agree not to allow anyone other than those covered by my insurance to operate said vehicle. I shall deliver the vehicle to Planet on or before the date and time specified above for its return in as good mechanical and physical condition as when it was loaned to me, or pay Planet immediately for any repairs necessary to restore said vehicle to the same condition as when I received it. In the event of an accident involving said vehicle, I agree, within twelve hours following such accident, to furnish Planet with a full and complete report thereof and agree also upon demand, to reimburse Planet for any damage, cost or expense including reasonable attorney fees, in connection therewith. I agree that I will not authorize or incur any expense for the repair of said vehicle and that all claims and demands (including parking violations) arising from or relating to the use, possession or operation of said vehicle while in my custody are my responsibility and that I will pay the same. In the event that said vehicle is stolen while in my custody, I will immediately notify Planet of such theft. It is expressly understood by me that I have permission of Planet to operate said vehicle only during the period state above and that I shall not operate the vehicle beyond the date and time specified for its return. If legal action is taken to enforce this agreement, the prevailing party shall be entitled to recover reasonable attorney fees from the non-prevailing party.
