Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

How?	All financial companies need to share customers' personal information to run their everyday business. What we do

How does ET International, LLC protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does ET International, LLC collect my personal information?

We collect your personal information, for example, when you

- pay us by check or use your debit or card
- apply for a loan or show us your driver's license
- give us your income information

We also collect your personal information from others including credit bureau companies and other sources.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account unless you tell us otherwise

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *None.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *We only share your information with nonaffiliated lenders, insurance companies and other sellers of automotive products and services as authorized by you and allowed by Federal law.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *We do not jointly market.*
